THE ORCHESTRA'S OPENING NIGHT PERFORMANCE WAS THE MUSICAL CENTERPIECE FOR AN IMPORTANT MILESTONE IN RADIO HISTORY: THE INAUGURAL BROADCAST IN WHICH WQXR MERGED WITH NEW YORK PUBLIC RADIO. IN PARTNERSHIP WITH WQXR, ORPHEUS MADE ITS CARNEGIE HALL SERIES ACCESSIBLE TO A YEARLY AUDIENCE OF APPROXIMATELY 3.9 MILLION LISTENERS ACROSS METROPOLITAN NEW YORK. ORPHEUS WAS BROADCAST THROUGHOUT THE US ON SYMPHONYCAST AND PERFORMANCE TODAY, DISTRIBUTED BY 245 AMERICAN PUBLIC MEDIA AFFILIATES IN 40 STATES.
